FROM STREET ROAD:

- * **1. TAKE STREET ROAD EAST, PROCEED UNTIL YOU CROSS UNDER THE OVERPASS FOR I-95.**
2. MAKE THE FIRST LEFT AFTER THE I-95 OVERPASS ONTO DUNKSFERRY ROAD.
THIS IS THE EXPRESSWAY 95 BUSINESS CENTER.
- ** **3. MAKE THE FIRST LEFT ONTO PROGRESS DRIVE.**
4. MAKE THE FIRST LEFT AT THE THIRD DRIVEWAY.
THERE ARE TWO MAILBOXES BEFORE THE DRIVEWAY, ONE **FEDEx BOX** AND THE OTHER **DHL BOX**.
5. OUR OFFICE AT EXCEL PHYSICAL THERAPY IS LOCATED ON THE LEFT SIDE, LOOK FOR SUITE K.
THERE ARE SIX AVAILABLE PARKING SPACES FOR HANDICAP PATIENTS.

FROM I-95 NORTH AND ROUTE BLUE ROUTE (PHILADELPHIA):

1. TAKE I-95 NORTH TO THE EXIT FOR STREET ROAD.
2. AT THE LIGHT MAKE A RIGHT ONTO STREET ROAD.
- ** **3. GO TO LINE 3 IN THE ABOVE DIRECTIONS FOR "FROM STREET ROAD".**

FROM I-95 SOUTH (BUCKS COUNTY AND NEW JERSEY):

1. TAKE I-95 SOUTH TO EXIT FOR STREET ROAD.
2. AT THE STOP SIGN MAKE A LEFT ONTO STREET ROAD.
- * **3. GO TO LINE 1 IN THE ABOVE DIRECTIONS FOR "FROM STREET ROAD".**

FROM PENNSYLVANIA TURNPIKE:

1. TAKE EXIT 351 (PHILADELPHIA) TOWARDS US RTE. 1 SOUTH.
2. MAKE A SECOND RIGHT ONTO STREET ROAD (EAST).
- ** **3. GO TO LINE 3 IN THE ABOVE DIRECTIONS FOR "FROM STREET ROAD".**

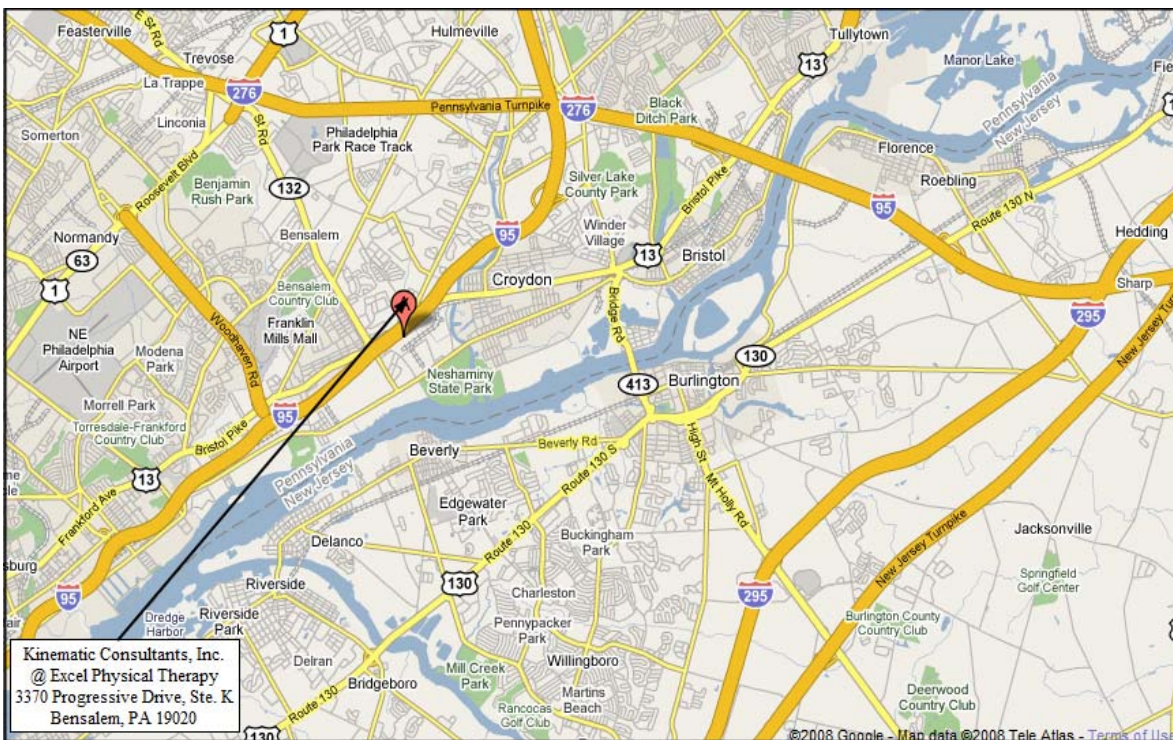
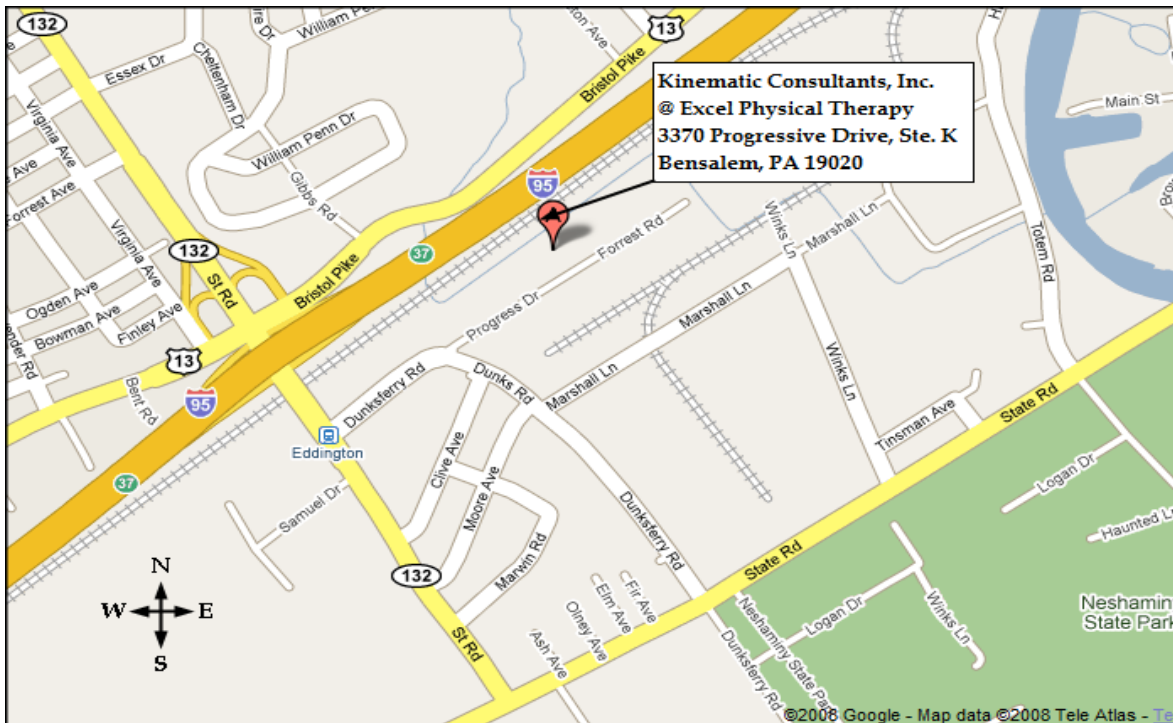
