### **FROM ROUTE 206:**

1. TRAFFIC LIGHT ROUTE 30 (WHITE HORSE PIKE) AND US ROUTE 206.
2. TURN RIGHT AND PROCEED TO THE NEXT TRAFFIC LIGHT FAIRVIEW AVENUE (RANERE ESTATES ON THE RIGHT AND WAWA ON THE LEFT).
3. MAKE A LEFT ONTO FAIRVIEW AVENUE AND PROCEED TO RAILROAD TRACKS (APPROX. ONE MILE).
4. CROSS TRACKS AND IMMEDIATELY BEGIN TO COUNT 4 STREETS ON THE LEFT SIDE.
5. TURN LEFT AT THE FOURTH STREET, MESSINA AVENUE.
6. MAPLE LEAF IS THE SEVENTH HOUSE IN ON THE LEFT SIDE (BRICK WALK IN FRONT).

### **FROM ATLANTIC CITY EXPRESSWAY:**

1. EXIT 28 HAMMONTON/VINELAND EXIT OFF OF ATLANTIC CITY EXPRESSWAY
2. BEAR LEFT AFTER (TOLL BOOTH) TOWARD HAMMONTON.  
PROCEED ON ROUTE 54 (12<sup>TH</sup> STREET) TO THE SECOND TRAFFIC LIGHT (FIRST ROAD – SUN BANK ON THE RIGHT AND ILLIANO’S RESTAURANT ON THE LEFT).
3. COUNTING FIRST ROAD AS THE FIRST INTERSECTION, PROCEED ONWARD TO THE FOURTH INTERSECTION (GRAND STREET – ML RUBERTON INSURANCE BLDG. ON THE LEFT SIDE).
4. MAKE A LEFT ONTO GRAND STREET AND GO TO THE THIRD INTERSECTION (PLEASANT STREET – THIS IS A RESIDENTIAL NEIGHBORHOOD SO DON’T LOOK FOR COMMERCIAL BUILDINGS).
5. TURN RIGHT ONTO PLEASANT STREET AND PROCEED 250 YARDS TO MESSINA AVENUE.
6. TURN LEFT ONTO MESSINA AVENUE AND PROCEED TO THE 7<sup>TH</sup> HOUSE ON THE RIGHT HAND SIDE. YOU WILL SEE THE MLPT PARKING LOT AND BRICK SIDEWALK.

### **FROM BERLIN:**

1. ROUTE 30 (WHITE HORSE PIKE) EAST (TOWARD ATLANTIC CITY) FROM BERLIN.
2. PROCEED ON 30 APPROX. 12 MILES TO FAIRVIEW AVENUE IN HAMMONTON.  
(TOMASELLO WINERY ON THE LEFT AND WAWA ON THE RIGHT)
3. MAKE RIGHT ONTO FAIRVIEW AND PROCEED TO RAILROAD TRACKS (APPROX. ONE MILE).
4. CROSS TRACKS AND IMMEDIATELY BEGIN TO COUNT 4 STREETS ON THE LEFT SIDE.
5. TURN LEFT AT THE FOURTH STREET, MESSINA AVENUE.
6. MAPLE LEAF IS THE SEVENTH HOUSE IN ON THE LEFT SIDE (BRICK WALK IN FRONT).

### **FROM ATLANTIC CITY:**

1. ROUTE 30 (WHITE HORSE PIKE) WEST (TOWARD CAMDEN) TO INTERSECTION OF ROUTE US 206 AND ROUTE 30.
2. PROCEED ONWARD APPROX. ½ MILES TO THE NEXT TRAFFIC LIGHT WHICH IS FAIRVIEW AVENUE (RANERE ESTATES ON THE RIGHT AND WAWA ON THE LEFT).
3. MAKE A LEFT ONTO FAIRVIEW AND PROCEED TO RAILROAD TRACKS (APPROX. ONE MILE).
4. CROSS TRACKS AND IMMEDIATELY BEGIN TO COUNT 4 STREETS ON THE LEFT SIDE.
5. TURN LEFT AT THE FOURTH STREET, MESSINA AVENUE.
6. MAPLE LEAF IS THE SEVENTH HOUSE IN ON THE LEFT SIDE (BRICK WALK IN FRONT).

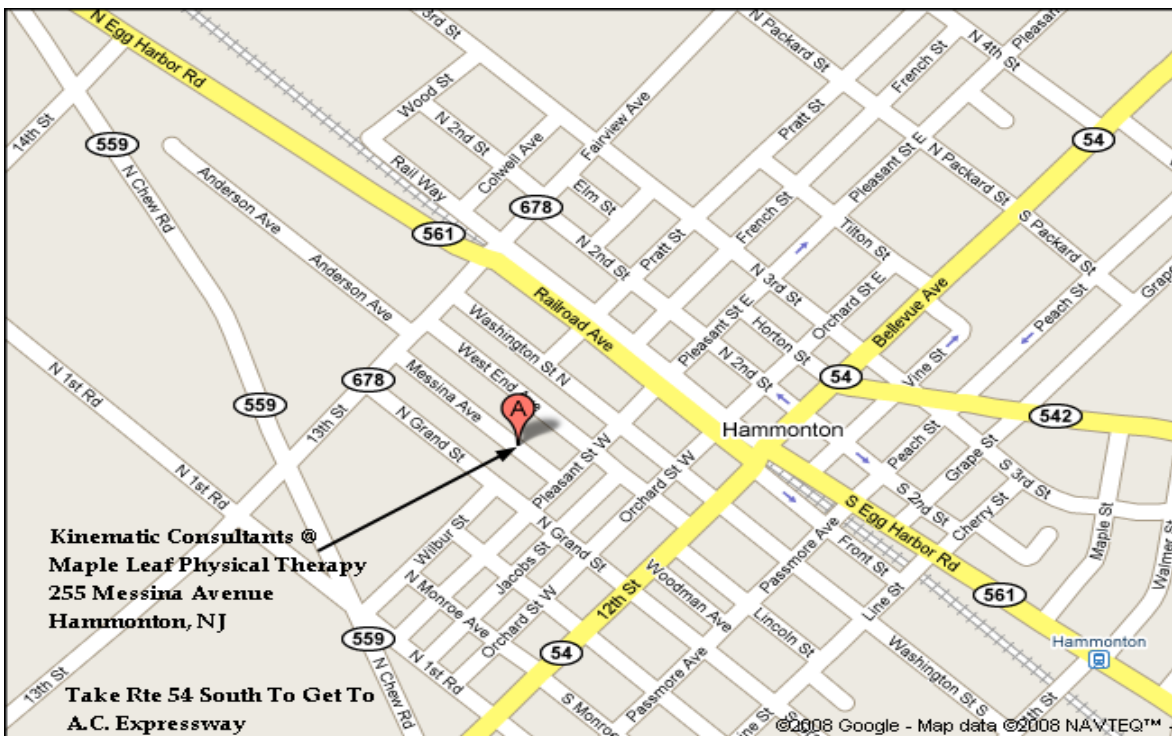
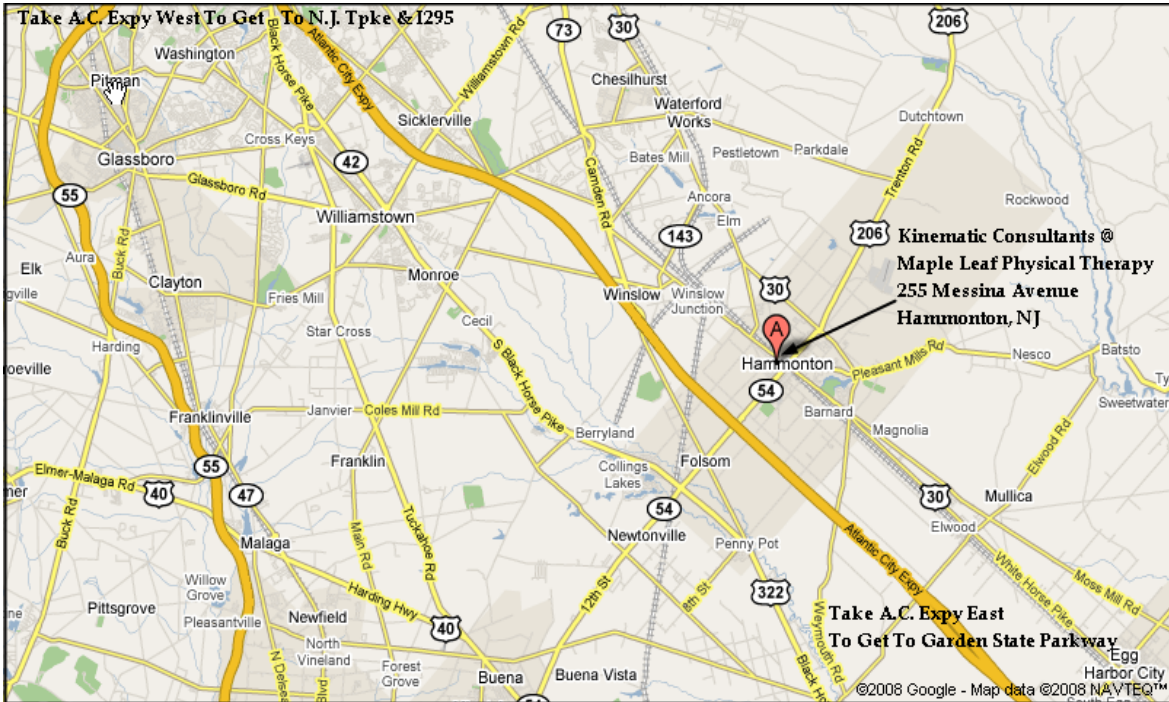
