FROM GARDEN STATE PARKWAY (GSP) SOUTH:

1. TAKE GSP TO EXIT 159 (INTERSTATE 80; SADDLE BROOK; G. WASHINGTON BRIDGE)
2. AFTER TOLL, STAY TO THE LEFT AND FOLLOW SIGNS TO I-80 EAST TO G. WASHINGTON BRIDGE.
- *** 3. GO TO LINE 3 IN THE BELOW DIRECTIONS FOR “FROM GSP NORTH”.

FROM GARDEN STATE PARKWAY (GSP) NORTH:

1. TAKE GSP TO EXIT 159 (INTERSTATE 80; SADDLE BROOK; G. WASHINGTON BRIDGE)
2. MERGE ONTO I-80 EAST TO G. WASHINGTON BRIDGE.
- *** 3. STAY IN LOCAL LANES FOR I- 80 EAST. FOLLOW APPROXIMATELY 1.3 MILES TO EXIT 63 (ROUTE 17 NORTH; ROCHELLE PARK; PARAMUS).
4. AT THE STOP SIGN MAKE A LEFT ONTO RIVERVIEW AVENUE.
5. GO TO ESSEX STREET AND MAKE A RIGHT.
6. ONE BLOCK DOWN ON THE LEFT IS THE ROCHELLE PARK MED-REALTY BUILDING. IT IS THE BUILDING BEFORE THE HARLEY DAVIDSON MOTORCYCLE OF BERGEN COUNTY BUILDING.

FROM ROUTE 17 SOUTH:

1. TAKE RT-17 SOUTH.
2. TO ESSEX STREET EXIT (MAYWOOD/PATERSON)
3. KEEP RIGHT AT THE FORK, FOLLOW SIGNS FOR I-80 WEST.
4. TURN RIGHT AT ESSEX STREET
5. ONE BLOCK DOWN ON THE RIGHT IS THE ROCHELLE PARK MED-REALTY BUILDING. IT IS THE NEXT BUILDING AFTER THE HARLEY DAVIDSON MOTORCYCLE OF BERGEN COUNTY BUILDING.

FROM ROUTE 17 NORTH:

1. TAKE RT-17 NORTH.
2. TO ESSEX STREET EXIT (ESSEX STREET/MAYWOOD/PATERSON)
(HOME DEPOT AND NATIONAL WHOLESALE LIQUIDATORS WILL BE ON THE RIGHT, JUST BEFORE THE EXIT.)
3. YOU WILL DRIVE OVER ROUTE 17 TO A LIGHT. PROCEED THROUGH THE LIGHT.
4. ONE BLOCK DOWN ON THE RIGHT IS THE ROCHELLE PARK MED-REALTY BUILDING. IT IS THE NEXT BUILDING AFTER THE HARLEY DAVIDSON MOTORCYCLE OF BERGEN COUNTY BUILDING.

FROM ROUTE 80 WEST:

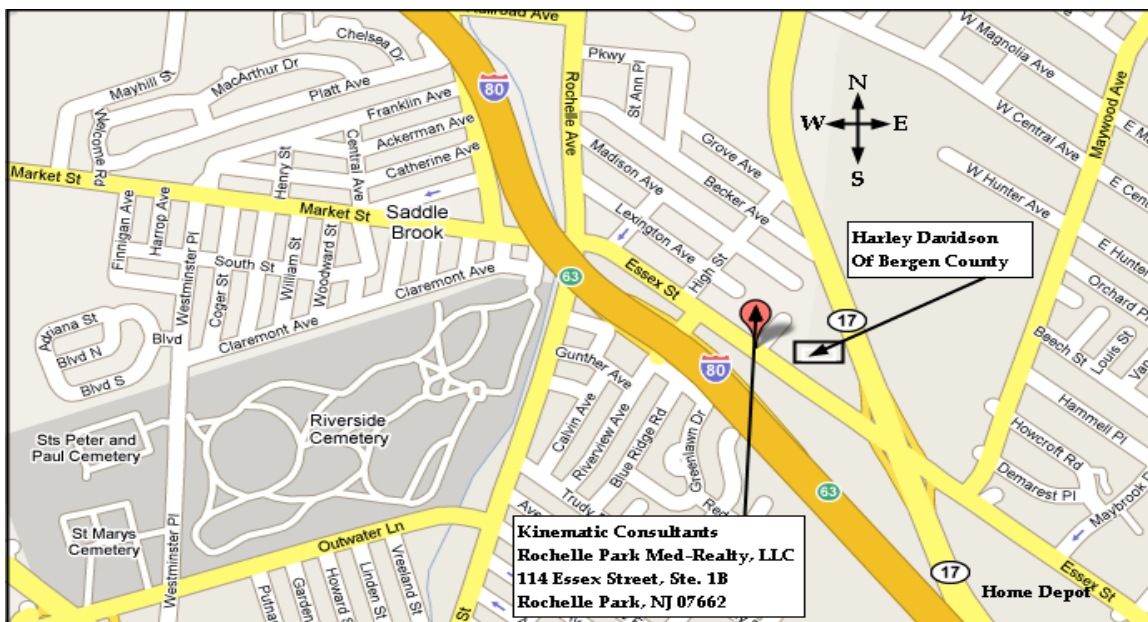
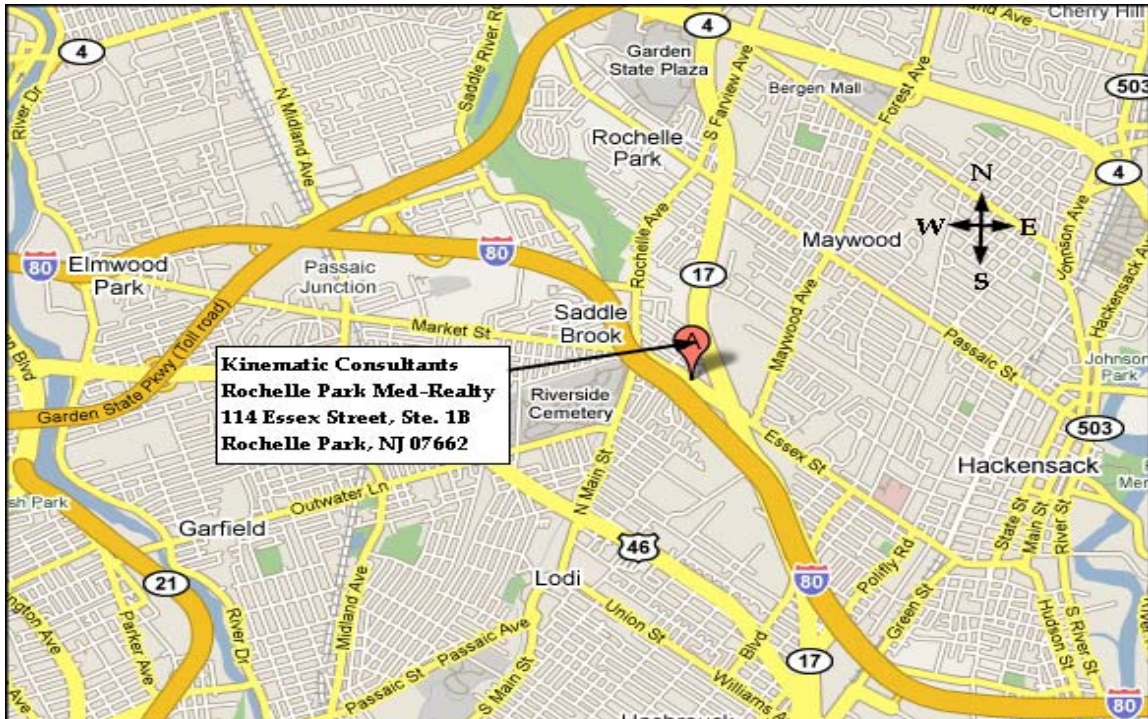
1. TAKE I-80 WEST TO EXIT 63 (ROUTE 17/ ROUTE 4/ LODI/ FAIR LAWN)
2. TURN RIGHT AT RIVERVIEW AVENUE.
3. TURN RIGHT AT ESSEX STREET.
4. ONE BLOCK DOWN ON THE LEFT IS THE ROCHELLE PARK MED-REALTY BUILDING. IT IS BEFORE THE HARLEY DAVIDSON MOTORCYCLE OF BERGEN COUNTY BUILDING.
